## **REQUIRED REPORTING ON CARES ACT EMERGENCY STUDENT GRANTS**

## Updated: August 10, 2020

Section 18004(c) of the CARES Act requires institutions to use no less than 50 percent of the funds received from Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care). Accordingly, the following information must appear in a format and location that is easily accessible to the public 30 days after the date when the institution received its allocation under 18004(a)(1) and updated every 45 days thereafter:

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

**RESPONSE:** Barton College signed and returned to the Department the Certification and Agreement on April 24, 2020. The College intends to use no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

**RESPONSE:** Barton College received \$580,659 on April 27, 2020 from the Department pursuant to the College's Certification and Agreement for Emergency Financial Aid Grants to Students. This amount represented 50% of the total amount of funds received by the College under Section 18004(a)(1) of the CARES Act.

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

**RESPONSE:** The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of May 26, 2020 is \$0 and as of July 10, 2020 is \$580,659.

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section18004(a)(1) of the CARES Act.

**RESPONSE:** The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 as of March 13, 2020 was 809.

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

**RESPONSE:** The total number of students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of July 10 is 809.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

**RESPONSE:** Barton College allocated \$493,125 of the grant amount equally to eligible students with cash payments of \$625 to each eligible student who was enrolled at the College on March 13, 2020 and held \$87,534 for students to apply for additional emergency aid. Students were instructed to inform the College if they did not incur eligible expenses, as defined by the U.S. Department of Education, or if the student for any other reason declined the grant. All funds were disbursed to eligible students as of July 10, 2020.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.
